**NOTICE OF FILING FOR THE 2018 STATE GENERAL ELECTION
ISANTI COUNTY, MINNESOTA**

The following is a notice of federal, state, and county offices that will be voted for at the state general election to be held on Tuesday, November 6, 2018. The filing period for these offices begins at 8:00 a.m., Tuesday, May 22, 2018 and ends at 5:00 p.m., Tuesday, June 5, 2018.

Note: Filing offices will be closed Monday, May 28, 2018 in observance of Memorial Day.

The place of filing for federal offices is the Office of the Secretary of State, State Office Building, Room 180, 100 Rev. Dr. Martin Luther King Jr. Blvd, St. Paul, MN 55155-1299.

The place of filing for state offices is with the Office of the Secretary of State or with the county auditor of the county in which the candidate resides.

The place of filing for county offices is the Isanti County Auditor-Treasurer's office, 555 18th Avenue SW, Cambridge, MN 55008.

Candidates may file in person or by mail if the filing is received during the filing period. Candidates who will be absent from the state during the filing period and meet the requirements of Minnesota Statutes section 204B.09, subdivision 1a, may arrange to file during the seven days immediately preceding the candidate's absence from the state.

This notice is provided pursuant to Minnesota Statutes section 204B.33.
