5. SCHEDULED BUSINESS:

- A. **LAND OPTION** Jim O'Brien came before the Board to present his proposal for the sale of a portion of his land that basically borders the west township land. His asking price is \$20,000 = \$3,000 (fees) + \$17,000 (land cost)

 The Board would like to schedule the sale of the Township north land (13acres) to coincide with the purchase of the O'Brien land. Jim will talk to the Township Attorney (Jake Peterson) about drawing up a purchase agreement for the O'Brien land. Jim will also talk to a number of realtors regarding the value of the Township land (13 acres) with a building site.
- B. **PARK LAND** on Palisade Dr there has not been any feedback from the Isanti County Attorney. The park land belongs to Isanti County and does have a covenant on it.

7. NEW BUSINESS AT PUBLIC REQUEST:

A. **JACOB FABIAN** – came before the Board to ask if anything can be done to reduce the speed of vehicles on 328th Ave. The Board will look into the situation regarding the number of driveways and how far apart they are to see if 328th Ave or sections of 328th Ave qualifies for the township to reduce the speed limit.

8. ROAD BUSINESS

- A. ROB'S REPORT:
 - i) 2017 Ford F-450 windshield replacement the clerk has received an invoice for the repair. After a check is written the clerk will submit the bill to MATIT insurance for reimbursement.
 - **2017 Ford F-450** an aluminum ladder has been built to aid in the entering and exiting the contractor box on the truck.
 - ii) **Snowplowing** He reports a minimum of snowplowing and mainly salting intersections.

- iii) **Brush mowing** Rob has contacted Bart of Perkins Enterprises (dba: Shermik Tree Farms, LLC) and he has completed the brush mowing since Tom Lundeen's equipment has needed repair.
- iv) **WORKERS' COMPENSATION INCIDENT:** Todd reported that all medical bills have been paid.
- v) **TURNAROUND AGREEMENTS** previously signed turnaround agreements need to be filed in the township office.
- vi) **Fish Lake Township / North Pine Lake Road Project** Rob notified the Board that Fish Lake Township is looking into getting a bond to reconstruct and pave North Pine Lake Road in 2026. Cambridge Township has about 1400' of North Pine Lake Road that is in the Township. The estimate for Cambridge Township's share would be approximately \$80-90,000.

No action was taken at this time.

- vii) Veit Disposal did send an email to the township that was forwarded to Rob requesting Spring road restrictions.
- viii) **Fjeldheim Road North of Co. Rd 6** trees have grown and are hanging over the road on a 250-300′ section of Fjeldheim Road. Rob received a number of quotes to remove the trees, brush and grind stumps approximately 7 feet back from the shoulder of the road. The following quotes were received:

1) Haven Stump Removal, Inc \$5,000 2) Tom Lundeen (no stump grinding) \$5,500

Supervisors would like to go to the location and review what the project entails. The clerk is to put this project on the agenda for the Audit and Budget meeting (2/16/2024). Jim will also be receiving a quote at that time from Tree Fellers.

- ix) MNDOT Rob notified the Board that Lucus from the State Highway Dept. would like to have a meeting in the first week of April regarding the future highway 65 project (2026) thru Grandy.
- x) **357**th **AVE** going West from State Hwy 65 there is an area of about 1300' of lowland and the paved road is getting rutty. Rob received the following estimates for the Board to consider:
