C. The Township received reports from First Bank & Trust showing a collateral insurance amount to cover 110% of the uninsured savings dated **3/31/2025**. They check the deposit balances every business day at 2pm CST and make pledge changes accordingly at that time. (Minn. Stat. 118A.03). This program will be discontinued and the new program **intrafi** will replace it – see below D Banking.

D. BANKING (INTRAfi PROGRAM):

Regarding the Cambridge Township accounts, First Bank and Trust was recently alerted to the fact that Federal Home Loan Bank (FHLB) is raising their cost to collateralize public funds significantly. Because public funds need to be fully insured, we are changing how we insure your funds. We will be using a program called **intrafi**. Instead of your funds being insured by pledged loans through FHLB, they will now be FDIC insured. All of your funds will remain in our bank, but we will need to set up shadow sweep accounts which will require signatures from you. Your interest rates will not change on your accounts.

A. **ROB'S REPORT:**

ii) **Road Salt for 2025 – 2026 Season** – Rob ordered 50 tons

iii) **Dust Control for Roads** – The township did receive an estimate from Central Minnesota Dust Control, LLC, for the application of dust control on township roads in 2025. The price estimate was \$1.26/gallon

Details: 33% Liquid Dustgard PLUS Magnesium Chloride
(Equivalent to 38.5% Calcium Chloride)

Price includes product, product application and any applicable taxes

Application rate of 0.30 or 1/3 gallon per square yard

Price per gallon = \$ 1.26

Price per foot = \$ 0.76

Price per mile = \$4,012.80

iv) **State of Mn/Grandy** – Rob met previously with a Mn State Highway representative in Grandy at the intersection of 368th Lane and State Hwy 65 to discuss future reconstruction in that area. State Hwy Dept gave an

estimate of **\$14,197.20** if they would include the cost in the reconstruction project scheduled for Hwy 65 in the near future. Rob met with two companies to get estimates for the work. Neither of the two companies could come close to the Mn State Highway estimate.

****NOTE:** A requirement of the Mn State Highway estimate is that the Township would need to cut a check for the estimated amount by **December 31, 2025**. The work is scheduled to be done in 2026.

- viii) **Cat 140H Grader repair** - Rob received an estimate for the repair of the R & R Moldboard Shift Cylinder from Lake State Repair LLC. The estimate consisted of 2 choices:
1. New replacement cylinder (\$7,330)
 2. Rebuilding cylinder (\$5,244)

- ix) **Cat 140H Grader wiring repair** – there is a wiring problem by the tilt wheel and Jim and Rob will follow up with the repair.
- x) **Grandy Nine Golf Course Road** – Rob is working with Craig Nystrom of the Grandy Nine Golf Course in repairing the water drainage concerns. Rob figures that the township will have \$2,000 - \$2,500 invested in the fix.
- B. **ROAD ORDINANCE REVIEW** – The Board will continue to work on reviewing & updating the Cambridge Township Road Ordinance 101 once all the various sections of the Comprehensive Plan have been finalized. Jim is on a Sub-Committee that will review the changes in the plan.
Multi Driveways – The present Cambridge Township Road Ordinance 101 states:
SECTION 10: DRIVEWAY AND MAILBOX POST
#9 Except for agricultural purposes, no single residential unit shall have more than one driveway.
The board is presently working on reviewing and updating the driveway section of the Ordinance 101. Jim will contact both MAT and private attorneys regarding the proper procedure that needs to be followed to change/update an ordinance.
- C. **UTILITY PERMITS** – The clerk reported that the township has issued 3 Utility Permit for the fiscal year 2025.
- D. **ROAD ITEMS NOT COMPLETE:**
 - i) **SPECIAL ASSESSMENT (2019)** – 34299 Hupp St. NE – culvert replaced
The assessment never got on the property tax statement
Dale will check into this once the tax statements for 2025 are out.
UPDATE: Dale reported that there is an assessment but does not explain the reason.
- E. **NORTH PINE LAKE ROAD** – Fish Lake Township has called a meeting with both Cambridge Township and North Branch Township to discuss the reconstruction and paving of North Pine Lake Road. The estimated cost of the project is \$ 1,540,515.00 of which they are requesting Cambridge Township to be responsible for \$ 128,850.00 (10%). Supervisor Jim Fridstrom will represent the township at the meeting scheduled for April 29th, 2025, 6:30pm @ Fish Lake Township Hall. Jim will check to see if they are still going to have the meeting.
- F. **ANNUAL ROAD REVIEW** – The board set the date for the Annual Road Review to be Saturday April 26, 2025 @ 8am. We will meet and start from the Cambridge Township Office/Garage.
- G. **2025 SPECIAL ASSESSMENT – DRAINAGE SYSTEMS (DITCHES)** – The township received a 2025 tax statement with an assessment owed to Isanti County by the township for a total amount of \$ 1,358.67 (\$679.34 due 5/15/2025 & \$679.33 due 10/15/2025).
